New Business:

- Price County Contract with Price County Productions
 - Biggest hold-up was with H&H study – Flambeau Engineering. Modifications of buildings need to follow engineer requirements to not modify flooding criteria.
 - Winter storage ran by Price County Productions with help from Fair Association with a donation to the fair. Price was raised to \$18 a foot.
 - Price County Fair Association will not have a “lease” it will be an “event agreement”. “During this Timeframe” Fair Association will have access to grounds for fair.

- Price County Productions will have one voting member on the Price County Fair Association board.
- Price County did budget monies to the Price County Fair Association for 2023.
- 2023 Price County Fair Discussion
 - Open for discussion for future fair events: Bulls N Barrels, Demolition Derby, and Fly Over are some ideas.
 - Discussion was held around carnival, food, and commercial vendors contracts.
 - Spirit Fair was brought up. It is tradition and they do participate in the Price County Fair also.
