December 6, 2022  
**Meeting Minutes**

**Meeting was called to order by Michelle Drobnik at 6:01 p.m.**

**Minutes:** A motion was made by Paul to approve the minutes from October 27, 2022, seconded by Kristy. Motion passed.

**Treasurer Report:** Rosanna provided treasurers report. A motion was made by Cassandra to approve the treasurers report, seconded by Jed. Motion passed.

**Budget:** Michelle presented a detailed budget to the board... Total estimated revenue for 2023 presented is \$81,700. Total estimated expenses for 2023 presented is \$77,050, with fair portion being estimated at \$54,000. A motion was made by Kristy to accept the budget as presented, seconded by Cassandra. Motion passed.

**The Dweebs:** Contract was presented for The Dweebs to perform on Thursday, August 24, 2023 from 7pm – 10pm after Karaoke contest. Motion was made by Paul to sign into contract with The Dweebs and write a deposit check, seconded by Kristy. Motion passed.

**Old Business:**

Dirt Dash / Derby insurance estimate was \$150 for the event which will be added to the current insurance policy. Contract was signed by Michelle and will be mailed immediately.

A contract from K&M Carnival was presented to the board for review. Will communicate final decision at January meeting after board members review contract.

Premium book will be reviewed for corrections and an addendum will be published.

Yeti Cooler has been raffled and \$700 has been added to the board funds.

Ross's Sports crossbow is currently being raffled on a \$20 a square board at Midway Tavern and will be moved to the Park Falls area in a couple weeks.

**New Business:**

Information was presented for Sunday (August 27, 2023) entertainment. Richie Yurkovich & Polkarioty from Willard, WI – 2 polka performers for \$500 from 11am – 1pm. Roger Lee, country soloist from Winter, WI for \$300 from 2pm-4pm. Motion was made by Paul to book Richie Yurkovich & Polkarioty and Roger Lee for Sunday entertainment, seconded by Kristy. Motion was passed.

Convention – Motion was made by Kristy to sign for fair activities during convention within reasonable cost, seconded by Cassandra. Motion passed.

Motion was made by Paul to purchase an iPad mini for gate passes, seconded by Cassandra. Motion passed.

Discussion about the fair possibly doing a concession stand at the Rodeo (June 30 – July 1)... idea is to do spray painting cowboy hats.
